AMENDMENT TO THE FAIRWAYS AT FIELDCREEK RANCH DECLARATION OF PROTECTIVE COVENANTS

RECITALS

Paragraph XI E. of the Declaration permits amendments to be made thereto upon the affirmative vote of fifty-one percent (51%), a majority, of the then owners of all Lots in the development entitled to vote, said owners being members of the Association, and at least fifty-one percent (51%), a majority, of said Lot owners/members of the Association have given their affirmative vote approving this Amendment, as evidenced by the records of the Association.

NOW, THEREFORE, the Association hereby amends the Declaration as follows:

Paragraph VI L. <u>Assessment for Fieldcreek Ranch Homeowner's Association</u> is hereby deleted in its entirety.
